Circular R&C-CFA No. 75/12-13

Subject: Centrex facility through FTTH services and rent free incoming connections on Centrex group on FTTH– reg.

Kindly refer BP-Enterprise unit circular no. 111-05/2012-BP-Ent dated 30-04-2012, vide which under para 2.5, the tariff for Centrex facility to the voice connections on FTTH in a particular complex of one or more buildings was issued.

2. In order to promote the Centrex facility on FTTH, **following has been decided by the competent authority:**

- Centrex facility charges to the voice connections on FTTH in a particular complex of one or more buildings may be waived off if size of the Centrex group is >50 connections.**
- Rent free incoming connections for Centrex group on FTTH to Corporate customers/Multistorey complex/Housing Societies etc. may be provided for the use of incoming calls and making calls within Centrex numbers only i.e. no outgoing calls out of Centrex, subject to fulfillment of following conditions:-**

| Size of Centrex group | Rent free incoming connection |
|--------------------------------------|--|
| 15-25 | 01 |
| 26-50 | 02 |
| 51-100 | 03 |
| For every additional 100 connections | 1 additional connection in addition to above |

- The security deposit and installation charges shall be same as applicable to normal DEL.
- All other terms and conditions, as mentioned in earlier circulars, shall remain unchanged.
- These instructions shall **have immediate effect in all the circles.**
- This circular is issued based on the approval of Competent Authority in Broadband Cell File No. 64-133/BB/Tariff/11-12/Pt.2. **Clarification/correspondence, if any, in respect of above tariff may be sent to Broadband Section, BSNL, Corporate Office, Janpath, New Delhi-110001, Tel.
