**Circular R&C-CFA No. 111/14-15**

**Subject: Discounts to BBNL on the FTTH Broadband connections provided at Gram Panchayats (GPs) under NOFN Project to carry out the acceptance testing and to assess the stability of the broadband services on the network-eg.**

1. Following has been decided by competent authority:

**a) To offer discounts to BBNL on the FTTH Broadband connections under any BB plan provided at Gram Panchayats (GPs) under NOFN project to carry out the acceptance testing and to assess the stability of the broadband services on the network.**

**(i) Since ONT is supplied and installed by UTL/BBNL, security deposit, installation charges and monthly charges for ONT may be waived off.**

**(ii) Security deposit for FTTH BB plan may be waived off.**

**b) The above FTTH BB connections may be provisioned based on the requisition issued by PMUs of BBNL at Circle level.**

**c) The monthly bill may be generated as a single corporate connection for all the connections together in a Circle.**

2. All other terms and conditions shall remain unchanged.

3. These instructions shall **be effective w.e.f. 23-03-2015 in all circles.**

4. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-133/2014/FTTH-BB.
