




Circular R&C-CFA No.73/17-18

Subject: Introduction of a scheme to waive off Installation charges for new LL/DSL/FTTH connections (voice/Broadband/combo) in all the Circles -reg.


1. In order to increase LL/DSL/ FTTH connection base, to utilize spare FTTH capacity and to proactively achieve the LL/DSL/FTTH connection, the Competent Authority has decided **“to introduce a scheme to waive off installation charges for the new LL/DSL/FTTH connections (voice/ Broadband/combo) in all the circles, for a period of one year.”**
2. **The Circles shall ensure to comply with all regulatory mechanism.**
3. All other terms and conditions shall remain same as per earlier circulars.
4. These instructions shall **be effective with immediate effect for a period of one year in all the Circles.**
5. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-402/2016-17/BB/Tariff.
