Subject: Introduction of new Circle specific Standalone DSL Broadband plan '5GB CS334', restoration of PAN India DSL Broadband plan '35GB Plan', restoration/revision of Circle specific FTTH Broadband plans 'Fibro Combo ULD 2999 CS64' & 'Fibro Combo ULD 4999 CS66' and withdrawal of FTTH Broadband plan 'Fibro Combo ULD 1495 CS138' in Maharashtra Telecom Circle only-reg.

- CGMT MH Circle may kindly refer to his office proposal vide letter No. CGMT/MH/MKTG& SALES -CFA/SSA Proposals/2017-18/24 dated 23-01-2019 and e-mails dated 02-02-2019 & 04-02-2019 regarding for review of CFA plan both PAN India and Circle specific LL/BB (DSL/FTTH) plans.
- The proposal has been examined by the tariff committee and following has been decided by the Competent Authority:
 - To introduce new Circle specific standalone DSL Broadband plan '5GB CS334' on promotional basis for a period of 90 days in Maharashtra telecom Circle. The details of the plan are as follows:

Since all the DSL Broadband plans are available on FTTH with same tariff, DSL plan '5GB CS334' shall also be available on FTTH with same tariff.

- To restore DSL Broadband PAN India plan '35GB Plan' on regular basis in Maharashtra Telecom Circle.

- c) To restore the Circle specific FTTH Broadband plan 'Fibro Combo ULD 2999 CS64' with revised bandwidth/Name for all the existing as well as new customers on regular basis in Maharashtra Circle. Details are as follows:

- e) To withdraw Circle Specific FTTH Broadband plan 'Fibro Combo ULD 1495 CS138' for new customers in Maharashtra Circle.

Existing customers under above FTTH Broadband plan shall continue. However, efforts may be made to migrate these customers to some other DSL/FTTH Broadband plans.

3. Since all the DSL BB plans are available on FTTH with same tariff, the above plans shall also be available on FTTH with same tariff.
4. The Circles shall ensure to comply with all regulatory mechanism **including on line reporting to TRAI and also update the Circle website.**
5. These instructions shall **be effective with immediate effect in Maharashtra Circle only.**
6. All other terms and conditions shall remain unchanged.
