

<b>Fibro Combo ULD 5999</b>	Upto 30 Mbps till 400 GB, upto 2 Mbps beyond	Upto 60 Mbps till 1000 GB, upto 4 Mbps beyond
<b>Fibro Combo ULD 9999</b>	Upto 50 Mbps till 600 GB, upto 2 Mbps beyond	Upto 80 Mbps till 2000 GB, upto 6 Mbps beyond
<b>Fibro Combo ULD 16999</b>	Upto 100 Mbps till 800 GB, upto 4 Mbps beyond	Upto 100 Mbps till 3000 GB, upto 8 Mbps beyond
