Subject: Waival of Installation charges for new LL/DSL/FTTH connections (voice/ Broadband/combo) in all the Circles -reg.

1. In order to increase LL/DSL/ FTTH connection base, to utilize spare FTTH capacity and to proactively achieve the LL/DSL/FTTH connection, the Competent Authority has decided ***“to waive off installation charges for a period of 90 days, to the new LL/DSL/FTTH connections (voice/ Broadband/combo) in all the Circles”***
2. ***The Circles shall ensure to comply with all regulatory mechanism including online reporting to TRAI and also update the Circle website.***
3. All other terms and conditions shall remain same as per earlier circulars.
4. These instructions shall ***be effective with immediate effect for a period of 90 days, in all the Circles.***
5. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-445/2018/BB/Tariff.
