Subject: Organization Structure Re-design of BSNL


3. In the new organization structure, designations and roles of PGMs, GMs & DGMs in the Corporate Office and the new reporting structure of CGMs of non-territorial Circles would be as indicated in the Annexure.

4. To avoid dislocation of office work and to ensure a smooth transition to the new organization structure, the following guidelines will be strictly observed:

- i) The PGMs, GMs and DGMs will continue to discharge their duties and responsibilities as at present till the charge of the post is formally made over to the successor, wherever required.

- ii) The Officers will also perform the duties and responsibilities of their respective new roles during the transition period. Detailed job description of the new roles will be issued shortly.
- iii) Executives and Non-Executives below the DGMs will continue in their present place of posting and will continue to report as per the present arrangement till further orders.
