In such cases, a separate list may be got prepared and sent to this office.
- (iii) Any name to be added or to be deleted or names to be corrected may also be checked up and intimated along with reasons.
- (iv) Missing particulars in the columns Viz., date of birth and date of promotion may please be supplied to this office.
- (v) There may be cases of some executives whose circle of posting shown in the list may not be correct. In such cases, in respect of those executives who are working in your Circle, but their present circles of posting has been shown otherwise, particulars shown in the seniority list may be verified and correction, if any, may be intimated to this office, along with supporting documents.

- (vi) All concerned circles are requested to ensure that the substantive status of the Executives showing in the list are appearing as CAO(REGULAR) in the ERP to enable Vigilance Branch to furnish Vigilance clearance without loss of time.
