As per the details received from the Circles, there are total 168 vacancies available in the Circles as on date as candidates have not reported for document verification.

Hence, in view of the above, Competent Authority desires to take action for releasing the waiting list and ensure that:-

- The details of the candidates not reported for documents verification must be confirmed with the concerned Circles before releasing the list, once again.
- The waiting list should be released as per the available category wise vacancy.
- The remaining circles vacancy detail will be intimated, as soon as it is received from Circles concerned.
- SEA section should be intimated about the release of waiting list.
- Waiting list will consist of all those candidates who have qualified the examination but do not find a place in the merit list of successful candidates in the first list issued.
- Further, the existing guidelines, if any, may also be followed for releasing the waiting list.
