Subject:- Board level and below Board level posts including non-unionised supervisors in Central Public Sector Enterprises (CPSEs)- Revision of scales of pay w.e.f. 01.01.2007 – Payment of IDA at revised rates-regarding.

In modification of this Department's O.M. of even No. dated 06.04.2015, the rate of DA payable to the executives and non-unionized supervisors of CPSEs (2007 pay revision) is as follows:

(a) **Date from which payable:** 01.07.2015

(b) **Average AIC PI (2001=100) for the quarter March'2015 -May' 2015**

December, 2014	254
January, 2015	256
February, 2015	258
Average of the quarter	256

(c) **Link Point:** 126.33 (as on 01.01.2007)

(d) **Increase over link point:** 129.67 (256 minus 126.33)

(e) **Revised DA Rate w.e.f. 01.07.2015:** 102.6% $[(129.67 \div 126.33) \times 100]$

2. The above rate of DA i.e. 102.6% would be applicable in the case of IDA employees who have been allowed revised pay scales (2007) as per DPE O.M. dated 26.11.2008, 09.02.2009 & 02.04.2009.

3. All administrative Ministries/ Departments of the Government of India are requested to bring the foregoing to the notice of the CPSEs under their administrative control for necessary action at their end.
