Sub: Revision of pay of Board level and below Board level Executives w.e.f. 01.01.2007 – reduction of emoluments of directly recruited JTOs of 2007 and 2008 Batch & directly recruited JAOs in respect of whom result was declared in April-10.

Sir,

I am directed to refer to your office letter no. STE-500/Time Bound Promotion/Ruling File/2012-13/46 dated 18.1.2012 on the above cited subject and to state that recently with the approval of BSNL Board, the benefit of five advance increments on the minimum of the revised pay scale of Rs. 16400-40500 (E1 scale) has also been extended to JAO(Deptl.) who got promoted through internal competitive exam for which results were declared in 2010 (copy of order dated 20.12.2012 is enclosed).

The benefit of the above orders (i.e. 3.1.2012, 19.3.12 & 20.12.2012) is applicable from the date of joining the service in case of DR executives and from the date of promotion in case of departmental candidates. Thus, all the executives who belong to the JTO batches of 2007 & 2008 recruitment years and JAOs DR & departmental specified in the above mentioned orders are eligible to get the aforesaid benefit irrespective of the fact that they resigned or took VRS before the issue of said orders. As regard to the manner of recovery from such ex-employees in case the revised E-1A IDA scale is approved by Govt., it is to be stated that there is already a provision of obtaining an undertaking from such employees and excess amount, if any, may be recovered from such ex-employees by Administrative procedures such as Demand notices etc. However, in such cases, the undertaking may be obtained on Stamp paper of requisite value, duly notarised, before paying the arrears.
