Sub: Guidelines for hiring of building/premises for GSM BTS sites.

Ref: This office letter no. 69-18/2000-ESP dated 20/02/2001 (Copy enclosed (02 Pages)).

- A. With reference to captioned subject, the decision of Management Committee of BSNL Board was earlier conveyed vide this office letter cited under reference for constitution of empowered committee for taking building premises on rent for installation of GSM BTS equipments.
- B. Further, in response to some complaint, CVC advised BSNL to review the existing guidelines and make necessary changes.
- C. Accordingly, a committee was constituted at BSNL CO to review and recommend the modifications required (if any) in view of advice received from CVC.
- D. The recommendations of the committee have been approved by Director (CM) of BSNL Board.
- E. In view of above, the undersigned is directed to convey that the guideline issued vide letter no. **69-18/2000-ESP dated 20.02.2001** should be continued with the additional guideline that for hiring sites for mobile towers, the Empowered Committee and approving authority shall give an undertaking that they have no close relation with the Owner/ Land lord from whom proposal is being considered and approved. In case of any conflict of interest the Committee may be reconstituted appropriately.

List of relatives that shall come under purview of “**close relation**” is stipulated below:

- a. Member of Hindu undivided family (HUF)
 - b. They are Husband and Wife.
 - c. The one is related to other in the manner as Father, Mother, Son(s) & Son's wife (daughter in law), Daughter(s), Daughter's husband (Son in law), brother(s), brother's wife (Sister in Law), Sister (s), Sister's husband (Brother in law).
- F. This is issued with the approval of Director (CM) of BSNL Board.

Sub : IMPCS (Main) Project – Introduction of Cellular Services

As you are already aware, the tendering process for the IMPCS (main) tender is on and bids are scheduled to be opened on 2nd April 2001. The network is expected to rollout from October/November 2001 onwards. Some of the activities, which are identified as time consuming ones are in respect of SACFA clearance for the base stations and finalisation of rented space.

BSNL Board has considered these aspects and keeping targets for implementation of the project in view, has approved actions to be taken as outlined below:

SACFA CLEARANCE PROCEDURE

Broadly the siting clearance can be categorized as that required for BSNL and non-BSNL sites. Site clearance applications may be filed on the following lines:

- BSNL sites wherever tower exists shall be having site clearance requiring clearance for additional antennas. This can be initiated for clearance immediately by the circle.
- The BSNL sites where no tower exists, soon on opening of the tender, can be initiated by the circle, based on the maximum height of the tower proposed amongst all bidders.
- At non-BSNL sites, the sites, which are common amongst the various bids received can be applied for, immediately on opening of the tender.
- At other locations of non-BSNL sites, which do not fall under above category, to be applied only on the finalisation of the bids based on the information provided by the successful bidder.

Rented space finalisation

Although tender emphasized the need to locate base stations at BSNL premises, in spite of it, it is expected that many base stations shall have to be located at non-BSNL sites and efforts will have to be earnestly made to acquire these sites on rental basis in the minimum possible time frame. Accordingly a committee of following constitution, was decided to be empowered.

- A JAG level Officer – TDM or Area Director of the SSA, as the case may be - Chairman.
- JFA of the SSA concerned - Member
- Executive Engineer (Civil) - Member

The decision of the Empowered committee shall be final
